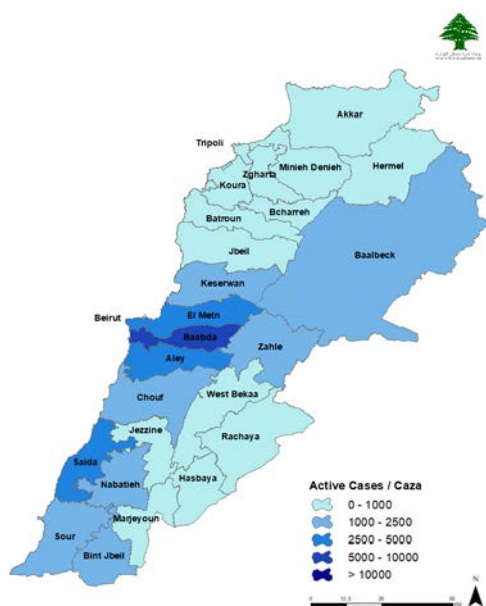

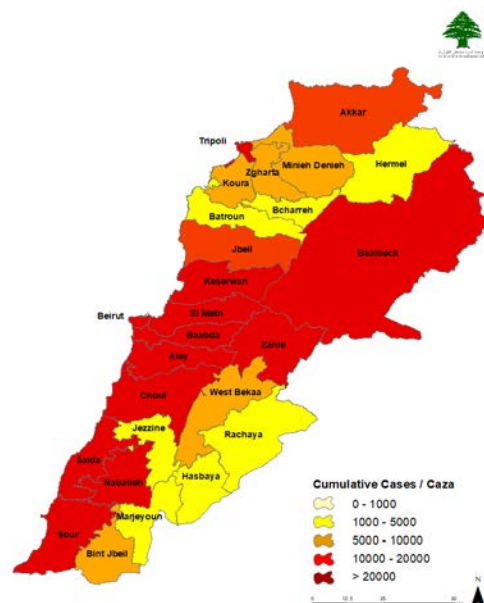

Distribution of Active and Cumulative Cases

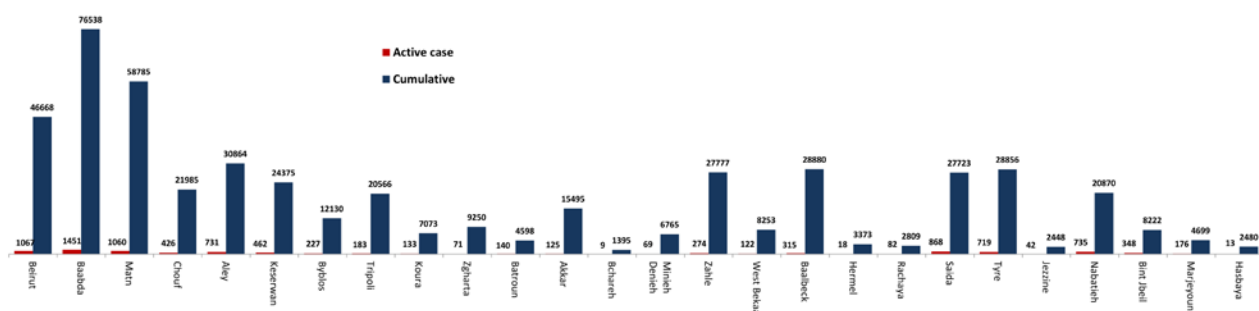
Distribution of Active Cases



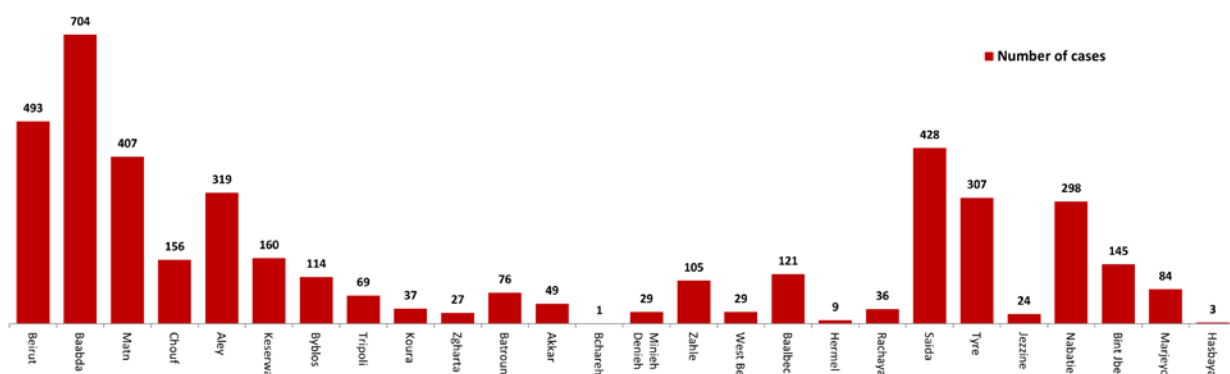
Distribution of Cumulative Cases

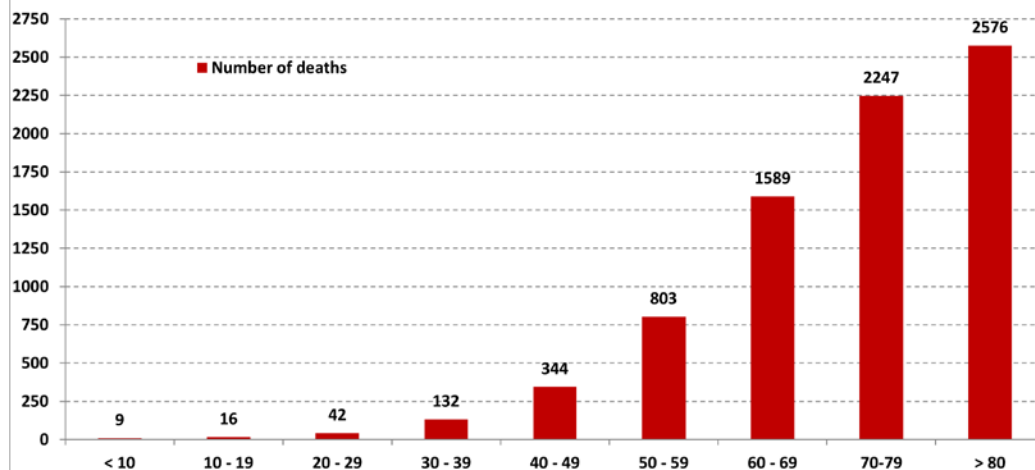
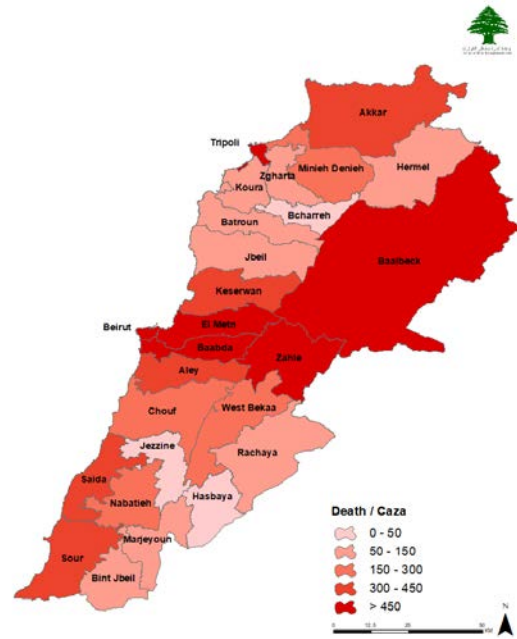

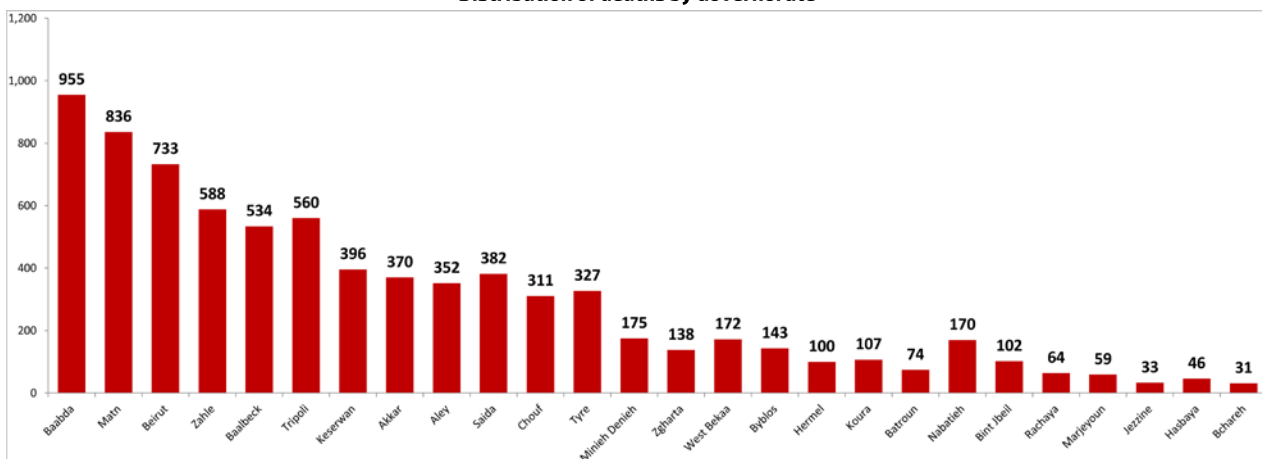

Distribution of deaths by Governorate

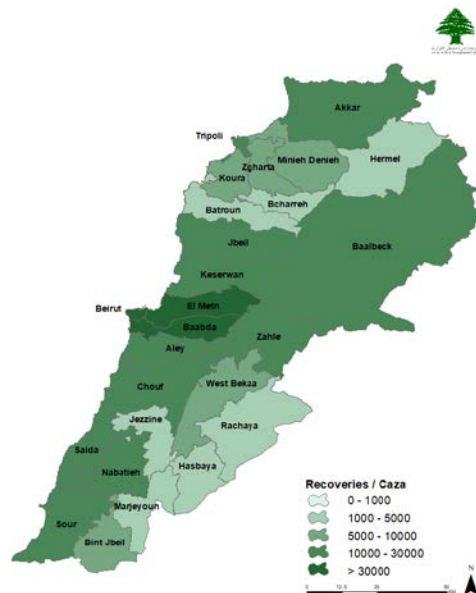

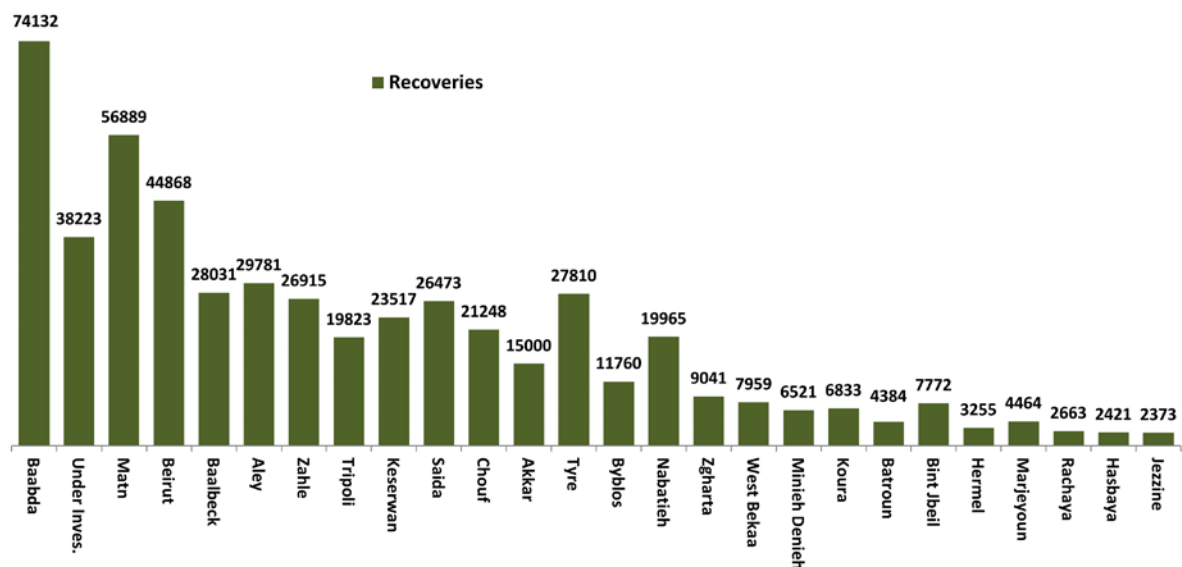

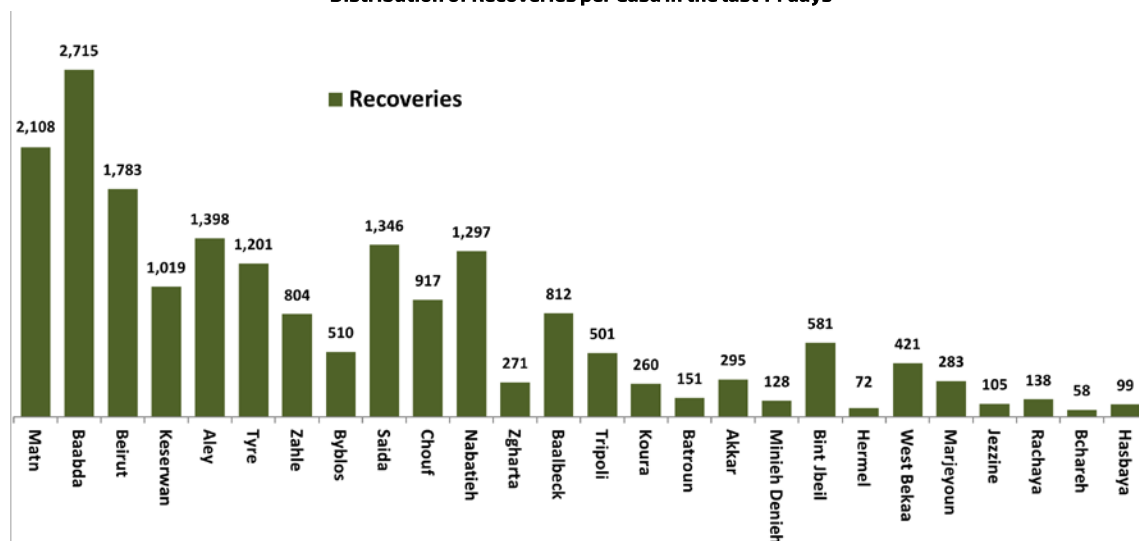
Distribution of Recoveries

- If you are not registered, you must bring any of the following identification documents: Identity card, passport, individual civil register, or any other identification document and the center will help you to register.

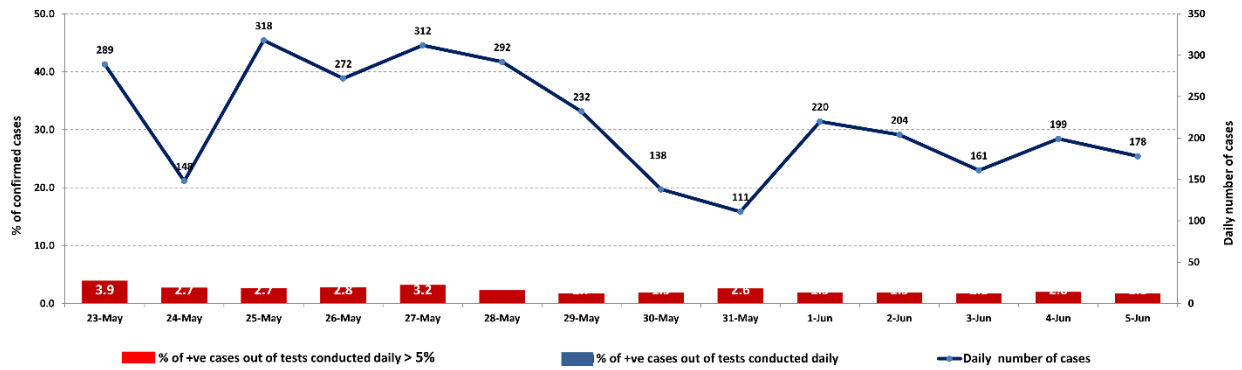

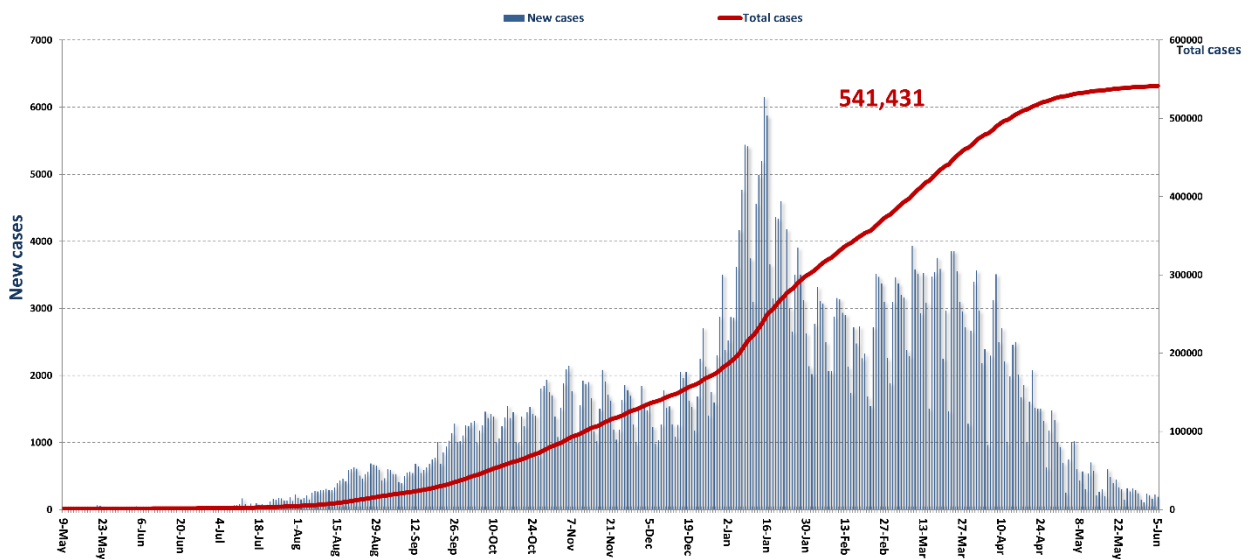

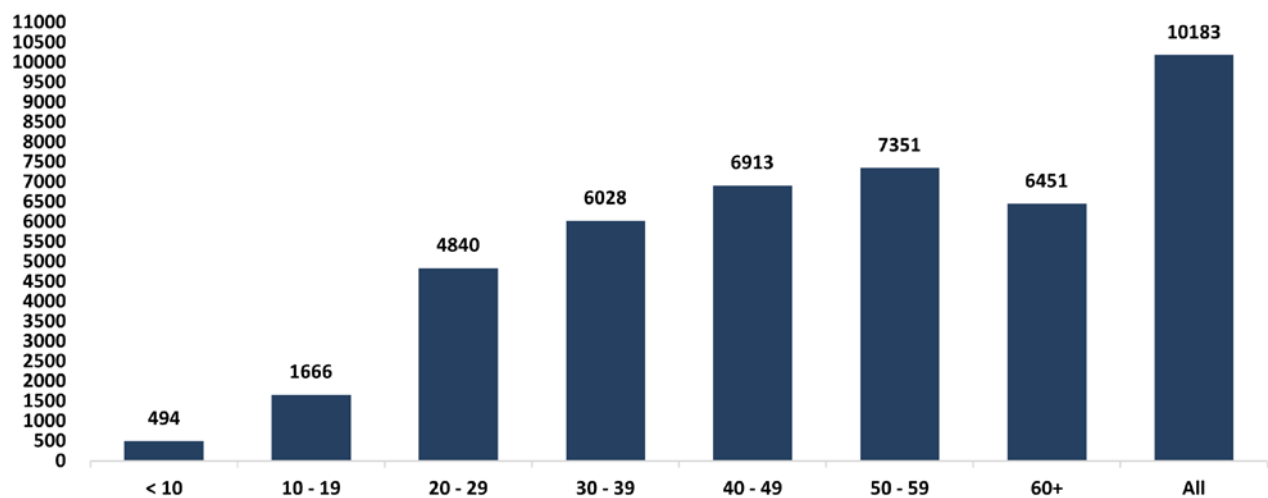
The percentage of positive cases out of the number of daily checks during the past 14 days

Decisions and actions taken during the past 48 hours

Ministry of Public Health

The Ministry of Public Health announced the organization of the Pfizer Marathon on Sunday, June 6, 2021, from eight in the morning until six in the evening in the following governorates: Akkar, Baalbek-Hermel, Bekaa, as a first stage, which will be completed in other governorates next week, in certain vaccination centers approved for the marathon, according to the conditions next

- Targeting the age group of sixty years and above (born in 1961 and below.)
- If the concerned person is registered on the vaccine platform, he must bring the identification document used in the registration process.
- In the event that he is not registered, he must bring any of the following supporting documents: ID - passport - individual record extract or any other identification document where the center will assist in registration.
- This marathon includes citizens and residents without exception.

The Minister of Health announced, during a ceremony in Nabatiyeh, the success in containing the Corona virus, and that the drug crisis will be resolved by the end of the week.

The Ministry of Public Health announced in a statement that Lebanon is considered one of the green countries in France, after the rate of the epidemic outbreak decreased

The Minister of Public Health discussed with a delegation of heads of associations of mukhtars in Lebanon, the board of directors of the cooperative fund and the coordinator of the Municipal Work Association, the inclusion of mukhtars within the national vaccination plan, so that it was agreed on a mechanism for the mukhtars to receive the vaccine within a week of submitting the nominal regulations to the Ministry of Public Health With registration on the official platform

The General Directorate of Civil Aviation issued Circular No. 24/2, whereby it amended the second clause to exempt passengers transiting the United Kingdom and Brazil wishing to come to Lebanon from the hotel reservation requirement in Lebanon.

The Directorate General of Civil Aviation issued Circular No. 19/2 in which it requested the following:

- All passengers coming to Lebanon from Brazil and the United Kingdom (except for those under 12 years old) must obtain a PCR test result from laboratories approved by the relevant authorities in the two countries, within a maximum of 96 hours, provided that passengers who do not have a negative test result are not allowed on the plane coming to Lebanon.
- All passengers coming to Lebanon from Brazil and the United Kingdom must have a hotel reservation for 5 days at their own expense in one of the hotels specified in the circular (you can view the circular on the website: <http://drm.pcm.gov.lb>)

The National Disaster Management Operations Room issued a statement related to updating the strategy to confront the Coronavirus and the stages of gradual easing of the closure restrictions in light of the positive development in the epidemiological reality in Lebanon and the decrease in the number of injuries, as the procedures within the public sector covered by the reopening and the continuity of work were modified according to the following:

The General Secretariat for the Presidency of the Council of Ministers issued the following statement: Based on Circular No. 5/2021 issued by the Prime Minister on 03/26/2021 by virtue of which he requested all public departments, public institutions and municipalities to approve work rotation with an attendance rate of no less than 50 % Of the total number of employees, employees and workers, and provided that it is left to the minister or head of administration to increase this percentage when necessary to ensure the continuity of the operation of the public facility until the issuance of a circular or a contrary decision, and as long as it has not issued any circular or contrary decision by the Presidency of the Council of Ministers, it continues This circular shall work without change or modification

The following recommendations were issued by the meeting of the Committee for Follow-up of Preventive Measures and Procedures for Coronavirus on 27/05/2021:

1. His result is negative 96 hours before the date of travel to Lebanon, provided that the expatriate undergoes another examination at Rafic Hariri International Airport and adheres to quarantine for a period of 4 nights / 5 days in one of the hotels specified by the Ministry of Tourism during which he is subjected to a PCR examination and is required to comply with home quarantine in case they are The result is positive.
2. The exclusion of national and foreign diplomatic missions from the aforementioned procedure for the hotel quarantine, provided that they adhere to the quarantine for a period of 5 days at their residence, as well as those coming from those countries to Lebanon who have received the second dose of the vaccine for a period of two weeks or have contracted the Coronavirus within a period of ninety On the day before the date of travel after they show an official document proving this.
3. Amending the timing of the opening of commercial complexes until 12:30 at night, as well as reopening the amusement center at the same time by 50% of their capacity, while adhering to all preventive measures and procedures for Coronavirus.
4. Allow the holding of all events (weddings, conferences, exhibitions ...) within open and closed spaces, provided that the number of attendees does not exceed 250 persons and 50% of its capacity, with the necessity to register the event on the IMPACT platform and the possession of all workers within it a negative PCR test result, it is also possible to conduct an Antigen scan for participants if the possibility is provided by the organizers.
5. Emphasis on the previous recommendation of a body that tightens the control of the tourism sectors under its authority, and to ensure its commitment to all obligations and preventive measures against the Coronavirus, and to take the necessary administrative measures against the violator, leading to closing it with red wax for a period of at least five days.
