












Cases per Day




Chronology of decisions according to number of cases






Number of individuals in home isolation and percentage of commitment to isolation






The distribution of PCR tests over governorates (exlcuding tests conduted in the airport)


Distribution of deaths by governorates




Distribution of deaths by age

Number of Cases by Location




Level of Preparedness of Public and Private Hospitals

Actions Taken at the Governorate and Municipal Level

Isolation centers approved by The Committee for the Follow up on Coronavirus Preventive Measures and Procedures Thursday, April 30, 2020

The committee responsible for specifying potential isolation centers includes an officer from the General Secretariat of the Supreme Council of Defense, a medical doctor in the army, an engineer from the army, and a representative from the Order of Nurses in Lebanon.

The committee a ims to inspect possible isolation centers in coordination with the concerned governorates and municipalities.

The National Committee recommended that governors and municipalities should monitor the implementation and operation of refugees' isolation centers that were a pproved in coordination with the Ministry of Public Health, the Ministry of Social Affairs, the Ministry of Interior and Municipalities, the United Nations High Commissioner for Refugees (UNHCR) and the United Nations Relief and Works Agency for Palestine Refugees (UNRWA) and through following the reference manual for the management of isolation centers that have been circulated by the Ministry of Interior and Municipalities.

Ministry of Public Health

- Issued a daily report on new cases and the status of existing cases in government and private hospitals.
- Implemented the health measures agreed upon within the Lebanese government's plan to return Lebanese expatriates during flights and at the airport, and defined the required isolation procedures according to the health status of expatriates in coordination with the Committee for the Follow up on Coronavirus Preventive Measures and Procedures, the Ministry of Foreign Affairs, the Ministry of Public Works and Transport, the General Directorate of Public Security and Middle East Airlines.
- Continues to equip government hospitals and others.
- Field examination of the hospitals and laboratories designated by the ministry to deal with the emerging coronavirus.
- Following up on the health situation of expatriates who have returned to Lebanon.
- Conducting and following up on conducted PCR tests for citizens in various Lebanese regions.
- The Ministry of Public Health has started increasing the number of PCR examinations and distributing medical supplies to government hospitals as part of its plan that focuses on random sampling every day in various Lebanese regions, which will allow to define the epidemic stage and take appropriate decisions.
- Received medical assistance from other countries to increase the capacity of hospitals and medical personnel.

Lebanese Red Cross

- 1048 new suspected cases were transferred to hospitals (18new cases)
- 1,315 trained paramedics

- 36 trained ambulance centers
- 11 additional ambulance centers ready to respond when needed
- 8,861 PCR tests transported to laboratories (445 new tests)
- 138 volunteers responsible for transporting PCR tests to laboratories
- 54,963 number of those benefiting from awareness sessions

Ministry of Foreign Affairs

- The ministry was informed that several expatriated donated money to governmental hospitals and the medical staff.
- The Ministry is following up with the Lebanese missions and consulates to organize the nominal regulations for expatriate students with limited financial capabilities who will be provided with financial assistance.
- The Ministry is coordinating with banks and BDL to tranfer money for students abroad
- following up with foreign missions on the departure of their citizens from lebanon
- The ministry is following up on the needed precaustions that should be followed by lebanese expats before traveling to lebanon from 28/4/2020 to 8/5/2020
- the ministry is following up on aids and donations presented by other countries to increase Lebanon's ability to respond to coronavirus

Security services (Internal Security Forces, General Security, State Security, Army, General Directorate of Civil Defense)

- The Lebanese army and other security services implemented strict measures on all Lebanese territory to ensure public mobilization.
- The army closed a number of shops, dispersed several public gatherings. The army also supported a number of municipalities in implementing precautionary measures. The army also shared the names of the 71 blocked roads by the municipalities. Also, the army distributed food units to families in need.
- General Security Forces followed up on the airport's set regulations for the return of Lebanese expatriates to their homeland and tracked potential cases in various Lebanese regions and ensured that they're adhering to the terms of home isolation. In addition, they dispersed several gatherings and aided several municipalities in issuing several written warnings to institutions and individuals that did not adhere to the decisions of the Council of Ministers. The forces also followed up on the return of 108 Lebanese citizens through the Al-Masna and Al-Aboudieh borders, Syria, in coordination with the Ministry of Public Health, the Ministry of Public Works and Transport, the General Directorate of the Internal Security Forces, the Lebanese Army and the Red Cross.
- ISF issued 205 fines, 182 were directed at cars that violated the car mobility decision, 17 were directed at individuals and 6 were directed at institutions that violated the public mobilization decision.
- The General Directorate of Civil Defense carried out 5 transportation mission for dialysis patients to hospitals based on the Minister of Interior and Municipalities Decision No. 479/2020. It also prepared 427 personnel and 67 ambulances, to interfere, when necessary, and transport those infected with the emerging coronavirus. The directorate also carried out sterilization missions in public and private areas that were excluded from the decision to close.
- State Security Forces visited different Lebanese regions and closed a number of shops. The forces also issues a number of warnings and followed up on cases in home isolations and announced that the extend to which Akkar, beirut and north governorates are following the public mobilization decision decreased by 65%. they also announced the Lebanese who entered the country on 5/5/2020 from its land borders have left the isolation centers after the results of the PCR tests camee out negative.

Ministry of Interior and Municipalities

- Issued Circular No. 6624 on 6/5/2020 announcing that Friday prayers and Sunday mass will be held, provided that the number of worshipers does not exceed 30% in the mosque or church.
- Implemented the extension of the general mobilization procedures according to the decision of the Council of Ministers that was issued on 5/5/2020 and that will remain active until 24/5/2020.
- The Ministry issued Memorandum No. 48 on 2/5/2020 regarding the implementation of the second stage of opening institutions according to the decision of the Council of

Ministers, which started on Monday 4/4/2020. the memo specified the opening hours for restaurants, provided that the percentage of customers does not exceed 30%, Barbers, car showrooms and car dealerships, with an emphasis on adhering to safety standards and the necessary preventive measures.

- Application of Memorandum No. 46 / 2020 issued by the Ministry on April 25/2020 related to amending the opening and closing times of industrial and commercial establishments according to Decree 6296 released on April 24-2020 (factories, wholesale markets, retail stores, Free professions, merchants and public transportation mechanisms)
- The Ministry issued the instructions for the electronic joint platform for municipalities (IMPACT) for evaluation, coordination and follow-up in order to facilitate the follow-up of health, social and security issues resulting from the coronavirus outbreak. The project is a partnership between the ministries of the Interior and Municipalities, Public Health, and Social Affairs and with the National Operations Room https://cp.interior.gov.lb
- Issued circular No. 6476 on 4/5/2020 specifying the need of sharing the name of the responsible municipality or the Union of Municipalities without mentioning any member's name when sharing food vouchers and food boxes.

Ministry of Socail Affairs

- The Ministry of Social Affairs, in cooperation with the Ministry of Interior and Municipalities, is completing the implementation of the first phase of the social emergency plan approved by the Lebanese government to help the poorest families in Lebanon. The army has finished distributing aid to families of public school students and those affected by mines. additionally, the distribution of aid to drivers of public cars will end in the next 48 hours. As for the poorest families, aid will be distributed to them starting Tuesday May 5.
- The Ministry of Affairs continuously checks all social services centers, care centers and health centers to ensure continuity in the provision of services to citizens, and to ensure that those in charge of the centers and their workers adhere to all safety standards and preventive measures required to counter the spread of the virus.

- The airport: All arrivals through Rafic Hariri International Airport are subject to health and security measures approved in the plan for the return of Lebanese expatriates by the Ministry of Public Health, the General Directorate of General Security and the General Directorate of Civil Aviation.
- Ports: Before allowing any vessel to enter the campus's harbor, the entire crew of the vessel is examined by a device approved by the Ministry of Public Health to ensure that there are no infections.

Ministry of Education and Higher Education

• The Minister of Education and Higher Education announced the cancellation of the intermediate exams. Students' names should be included in the list of nineth graders and should complete their academic year in order to obtain a certificate. the minister also announced that the school year should be completed betwen May 28 and July 2020. Students then take two months of summer break before resuming the new academic year in October.

Objectives of the National Operations Room

The National Operations Room works on coordinating efforts in order to accomplish the following goals:

- First Objective: Control the spread of the virus through the application of precautionary measures, minimize direct contact among people, and increase awareness of the population and access to information.
- Second Objective: Ensure the continuity of services at the national level and adopt and encourage remote working.
- Third Objective: Increase health sector capacity by continuously assessing available resources, gaps and look for funding and technical assistance to build up capacities and case management.

General Directions and Recommendations General Directions and Recommendations

- Implement the decisions issued by the Presidency of the Council of Ministers at the level of public and private institutions and municipalities.
- Stay at home and don't go out unless it is necessary.
- Frequently wash hands and follow all safety measures set by the Ministry of Public Health.
- Avoid crowded places and social contact and commit to a safe distance between individuals.
